RESOLUTION 2017-5

WHEREAS, the Town Board of the Town of Troy, Walworth County, Wisconsin, by this resolution, adopted on proper notice with a quorum and roll call vote of a majority of the Town Board present and voting resolves and orders as follows:

An emergency is declared on Booth Lake as exiting within the Town of Troy, Walworth County, Wisconsin for the following reason: High Water Due to Heavy Rains in Accordance and conformity with §166.23(1), Wis. Stats.

WHEREAS, the period of emergency shall be limited to the time during which the emergency conditions exit or are likely to exist on Booth Lake in the Town of Troy.

WHEREAS, the Town Board, or its designated agents, has the authority to order whatever is necessary and expedient for the health, safety, welfare, and good order of the Town of Troy during the emergency.

THEREFORE, BE IT RESOLVED, that the Town of Troy has instituted a temporary Slow-No-Wake (SNW) provision effective immediately on the waters of Booth Lake. This SNW provision will remain in full effect until such time the lake conditions warrant its removal as authorized by the Town of Troy Chairman.

HEREBY AUTHORIZES, the Town of Troy Water Patrol and other duly authorized officials, to enforce such provision.

BE IT FURTHER RESOLVED, that any person, who violates this lawful order of the Town Board or its agents made under this emergency declaration, shall forfeit not more than \$100.00 or, in default of payment of the forfeiture, shall be subject to imprisonment for 6 months for each separate offense.

The Town Clerk shall publish this resolution under §60.80, Wis. Stats., in a local newspaper. This resolution shall become effective upon adoption by the Town Board and the forfeiture penalties shall become effective upon publication.
