CHAPTER 16. AN ORDINANCE TO REGULATE THE PLACEMENT OF SIGNS

The Town Board of the Town of Troy DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Town of Troy Ordinance #2005-3 entitled Chapter 16 "An Ordinance Regulating the Placement of Signs" adopted on or about February 9, 2005 is hereby repealed and recreated as follows:

- 1. No signs shall be placed within the limits of any street, road, highway, or on any other public right-of-way, except for municipal traffic control, parking and directional signs.
- 2. No person shall place any sign upon or cause any sign to be placed upon any sign, guide board, mile post, signal, or maker erected by the State, the County or the Town for the warning, instruction or information of the public.
- 3. The Town hereby adopts Wis. Stat. Sec. 86.04, 86.19 and 86.191, and Wisconsin Administrative Code Chapter Trans 200 and 201.
- 4. Any person advertising a rummage sale shall include the date of sale and the address of said sale, shall not place said sign prior to twenty-four (24) hours prior to the commencement of said sale, and shall remove said sign within forty-eight (48) hours after the completion of said sale.
- 5. Any individual advertising an open house for the purpose of selling their real estate shall place the date of the open house on said sign, and shall not place said sign prior to twenty-four (24) hours to the commencement of the open hose, and shall remove said sign within forty-eight (48) hours of said open house. Real Estate, signs, and all other signs used for the purpose of selling real estate, shall be placed within the property limits of the real estate that is for sale.
- 6. Any person who violates any of the provisions of this Ordinance without the written consent of the Town Board shall be required to forfeit not less than ten (\$10.00) dollars nor more than one hundred (\$100.00) dollars.

and for a second or subsequent violation shall forfeit not less than ten (\$10.00) dollars nor more than five hundred (\$500.00) dollars.

This Ordinance shall be enforceable by the Town Board or any Town 7. Employee, and the same are free to remove any sign found to be in violation of this Ordinance.

SECTION 2: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.
