RESOLUTION NO. 2023-06

A RESOLUTION TO ALLOCATE AMERICAN RESCUE PLAN ACT (ARPA) FUNDS IN THE TOWN OF TROY FOR THE RADIOCOM P25 RADIO SYSTEM UPGRADE AS PRESCRIBED BY WALWORTH COUNTY.

WHEREAS, On March 11, 2021, President Biden signed into law the \$1.9 trillion relief bill known as the American Rescue Plan Act, also known as ARPA; and

WHEREAS, on May 10, 2021, the United States Department of the Treasury announced the launch of the Coronavirus State and Local Fiscal Recovery Funds (the "Fiscal Recovery Funds" or CSLFRF), established by ARPA, to provide \$350 billion in emergency funding for eligible state, local, territorial, and Tribal governments to recover from the COVID-19 pandemic; and

WHEREAS, The Town of Troy will receive \$248,169.14 from the federal government related to this program.

WHEREAS, the Town of Troy desires to utilize a portion of the allocation in the amount of \$138,749.02 for the Radiocom P25 radio system upgrade as prescribed by Walworth County to the Town of Troy.

NOW, THEREFORE, be it hereby resolved by the Town of Troy, Walworth County, Wisconsin, that:

Section 1. Expenditure of Funds. The following allocation of ARPA funding to fund government services under the replacing lost public sector revenue spending category as follows:
