ORDINANCE NO. 2023-06

AN ORDINANCE TO REPEAL AND REPLACE ORDINANCE NO. 2019-3 ENTITLED:

"AN ORDINANCE TO REQUIRE STOP SIGNS ON TOWNLINE ROAD AT THE INTERSECTION OF TOWNLINE ROAD AND THE BOOTH LAKE PUBLIC ACCESS DRIVEWAY AND THE PEDESTRIAN CROSSWALK"

WHEREAS, the Town Board for the Town of Troy has the authority to adopt traffic regulations pursuant to Wisconsin Statutes Section 349.06, in strict conformity with State traffic statutes and regulations; and

WHEREAS, Wisconsin Statutes Section 346.46 requires vehicles to stop at stop signs; and

WHEREAS, the Town Board finds that the public safety requires stop signs to be installed on Townline Road at the intersection of Townline Road and the Booth Lake parking area, where vehicles and pedestrians enter and cross Townline Road; and

WHEREAS, the Town Board finds that due to public safety issues four traffic calming devices such as speed bumps to be installed on Townline Road in four locations, with two to be installed north of and two installed south of the Booth Lake parking area, where vehicles and pedestrians enter and cross Townline Road; and.

WHEREAS, the Town Board for the Town of Troy finds it necessary and practical that these measures only be required when the Booth Lake Memorial Park Beach is in operation hereby establishes requirements as follows.

NOW THEREFORE, the Town Board of the Town of Troy, Walworth County, Wisconsin, does hereby ordain as follows:

SECTION 1: REPEAL: The Town of Troy Ordinance Number 2019-3 entitled, "An ordinance to require stop signs on Townline road at the intersection of Townline road and the booth lake public access driveway and the pedestrian crosswalk" is hereby repealed, Subject to Section 7, below.

SECTION 2: Operators of vehicles travelling in either direction shall stop at the posted stop signs in accordance with Sections 346.04(2) and 346.46, Wisconsin Statutes on Townline

Road at the vehicle and pedestrian intersection with the Booth Lake beach.

SECTION 3: The Town of Troy Public Works Supervisor is authorized and directed to post official signs giving notice of the foregoing obligation, in the form and manner required by Section 349.065, Wisconsin Statutes.

SECTION 4: The Town of Troy Public Works Supervisor is authorized and directed to install four speed bump traffic calming devices at the locations prescribed by the Town Board.

SECTION 5: The Town of Troy Public Works Supervisor is authorized and directed to install the stop signs and the traffic calming devices by the last day in April and removed by the last day of October of the year.

SECTION 6: Violations of this ordinance are subject to the forfeitures established for the comparable State offenses, including any variations or increases for second offenses as listed in the Revised Uniform State Traffic Deposit Schedule.

SECTION 7: CONTINUATION OF EXISTING PROVISIONS: The provisions of this ordinance, to the extent that they are substantively the same as those of the ordinances in force immediately prior to the enactment of this ordinance, are intended as a continuation of such ordinances and not as new enactments, and the effectiveness of such provisions shall date from the date of adoption of the prior ordinances. In addition, the adoption of this ordinance shall not affect any action, prosecution or proceeding brought for the enforcement of any right or liability established, accrued, or incurred under any legislative provision prior to the effective date of this ordinance for the time that such provision was in effect, and the repeal of any such provisions is stayed pending the final resolution of such actions, including appeals.

SECTION 8: SEVERABILITY: The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 9: EFFECTIVE DATE: This ordinance shall take effect immediately upon passage and posting or publication as provided by law.
