ORDINANCE NO. 2024-01

AN ORDINANCE TO REPEAL ORDINANCES 2005-1 AND 2010-1 RELATED TO PAYMENTS OF NOMINAL AMOUNTS AND AN ALTERNATIVE CLAIM PROCEDURE

WHEREAS, the Town of Troy Town Board recently adopted Ordinance 2024-01 related to the payment of nominal amounts and an alternative claim procedure; and

WHEREAS, the Town of Troy Town Board had previously enacted two separate ordinances related to these specific matters, Ordinance 2005-1 and Ordinance 2010-1, which are no longer necessary; and

WHEREAS, the Town of Troy Town Board finds that it is in the best interest of the health, general welfare, and safety of the Town of Troy to repeal the Town Ordinances which are no longer applicable.

NOW, THEREFORE, the Town Board for the Town of Troy, Walworth County, Wisconsin, **DOES ORDAIN AS FOLLOWS:**

SECTION 1: Ordinance 2005-1 entitled "An Ordinance for Payment of Nominal Amounts" is hereby repealed.

SECTION 2: Ordinance 2010-1 entitled "An Ordinance to Authorize Alternative Claim Procedure for Payment of Certain Bills and Vouchers" is hereby repealed.

SECTION 3: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 4: <u>EFFECTIVE DATE.</u>

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.
