RESOLUTION NO. 2025-02

A RESOLUTION CHANGING THE 2025 BUDGET OF THE TOWN OF TROY, WALWORTH COUNTY, WISCONSIN, ADOPTED BY A TWO-THIRDS MAJORITY VOTE OF THE ENTIRE MEMBERSHIP OF THE TOWN BOARD UNDER WIS. STAT. § 65.90(5).

WHEREAS, the Troy Center Fire Department and Town Board have been presented with a proposal from the Elkhorn Area Fire Department to purchase 6 Dual Band Portable Radios (including extended life batteries, and lapel microphones) and a 6-bank portable radio charger for a total cost of \$23,095.00,

WHEREAS, the Troy Center Fire Department and Town Board had already intended to augment the recent new radio equipment purchase using funds allocated in future budgets, and that the proposed equipment pricing is not affected by recent significant price increases of new radio equipment, and finding that the proposal is in the best interest of the health and safety of the residents of the Town of Troy,

WHEREAS, the Town of Troy 2025 Public Safety expense budget includes the amount of \$10,000 for the purpose of capital equipment purchases,

WHEREAS, the Town Board unanimously passed a motion made by Chairman Arntson and seconded by Supervisor Bord at the March 12, 2025 meeting, "to purchase 6 surplus Dual Band Radios at \$3,731.00 each and a 6-bank charger for \$707.05 for the Troy Center Fire Department utilizing \$10,000 of funding already in the budget and \$13,095.00, transferred from the Fire Department Capital Outlay Fund (Held in the Town of Troy General Fund) in the budget to cover the expenses".

NOW, THEREFORE, the Town Board of the Town of Troy, Walworth County does hereby resolve, and order as follows:

Section 1. That the sum of **\$13,095.00** is hereby transferred from the General Fund to the Public Safety expense budget for the purpose of purchasing 6 surplus Dual Band Radios and 6-bank charger for the Troy Center Fire Department.

Section 2. The Resolution shall be effective upon its adoption and approval.
