# A RESOLUTION AUTHORIZING THE TOWN OF TROY TO DESIGNATE AN ALTERNATIVE LOCATION WITHIN THE POLLING PLACE BUILDING FOR ELECTION DAY REGISTRATION.

**WHEREAS**, the Town Board of the Town of Troy is committed to promoting voter participation and ensuring accessible elections for all eligible citizens; and

**WHEREAS**, Election Day registration is authorized under Wisconsin law to allow eligible electors to register and vote at their polling place on Election Day; and

**WHEREAS**, Wisconsin Statutes § 6.55(2)(c) permits municipalities, by resolution, to designate an alternative location within the polling place building for Election Day registration, apart from the polling place itself, to facilitate the registration process.

**NOW, THEREFORE**, the Town Board of the Town of Troy, Walworth County does hereby resolve, and orders as follows:

## **Section 1.** Election Day Registration at Designated Location:

In accordance with Wisconsin Statutes § 6.55(2)(c), any person who qualifies as an elector and who is not registered and desires to register on the day of an election shall register at the following designated location:

When there is an overflow of registrants in the polling place, the registration election
official may direct registrant to the clerk's office adjacent to the polling place entrance
designated as an alternate location within the polling place building to facilitate the
registration process.

#### Section 2. Registration Procedure:

At the designated location, eligible electors shall execute a registration form as prescribed under Wisconsin Statutes § 6.55(2)(a) and provide proof of residence as provided under Wisconsin Statutes § 6.34. The signing by the person executing the registration form shall be in the presence of the town clerk, deputy clerk, or election registration official.

#### Section 3. Certificate Issuance:

Upon successful registration at the designated location, the town clerk or deputy clerk shall issue to the voter the completed registration form to be presented to the election officials of the proper polling place directing that the voter be permitted to vote.

## Section 4. Presentation of Registration:

The voter shall present the completed registration form to the election officials when the voter appears at the polling place.

## Section 5. Notice of Designated Location:

The town clerk shall prominently post a notice of the designated registration location at the polling place.

#### Section 6. Severability:

If any provision of this resolution or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this resolution that can be given effect without the invalid provision or application, and to this end the provisions of this resolution are severable.

## **Section 7.** Effective Date:

This resolution shall take effect upon adoption and proper posting or publication as required by law.
