RESOLUTION NO. 2025-10

A RESOLUTION AUTHORIZING A PROMISSORY NOTE LOAN NOT TO EXCEED \$19,500 FOR THE PURCHASE AND INSTALLATION OF A REMOTE MONITORING SYSTEM FOR THE TROY CENTER SANITARY DISTRICT #1 PUMP HOUSE.

WHEREAS, the Troy Center Sanitary District #1, is in need of funds of nineteen thousand five hundred dollars (\$19,500) for public purposes of improvements to the Troy Center Sanitary District #1 pump house and pump remote monitoring system; and

WHEREAS, the Town of Troy Board has deemed it necessary and in the best interest of the health, general welfare, and safety of the residents of the Troy Center Sanitary District #1 that, pursuant to the provisions of Section 67.12(12), Wisconsin Statutes, the sum of up to nineteen thousand five hundred dollars (\$19,500) be borrowed from The Town of Troy General Fund; and

WHEREAS, the Troy Center Sanitary District #1, will make a single lump sum payment on the borrowed amount during 2026, once replacement financing is arranged; and

WHEREAS, The Town of Troy will charge the Troy Center Sanitary District #1 interest on aforementioned loan at an annual percentage rate not to exceed <u>5.00%</u> accrued and due on a per diem basis to the date of final payment.

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Troy, Walworth County, Wisconsin, that the Troy Center Sanitary District #1 borrow from the Town of Troy, an amount not to exceed nineteen thousand five hundred dollars (\$19,500) for the purpose of financing the improvements to the Troy Center Sanitary District #1 pump house and pump remote monitoring system.

The Loan is to be payable in one lump sum that will include full principal and a rate of 5.00%, any accrued interest on a per diem basis to such payment date.

1.	Terms of Payment.	
	Town shall pay to Sanitary District the sum of \$19,500.00, as	a loan, for improvements to the Troy
	Center Sanitary District #1 pump house and pump remote mo	nitoring system.
2.	Terms of Repayment.	
	The life of the loan shall not exceed one year. In exchange for	the loan payment specified in Paragraph
	1, above, the Sanitary District will incur interest at an annual p	ercentage rate not to exceed 5.00% for
	the life of the loan. Payment will be made during 2026 in one I	ump sum. Payment will include full
	principal amount and all accrued interest on a per diem basis	to the date of payment.
3.	Satisfaction of Promissory Note.	
	When the Town receives payments in the sum initially paid by the Town to the Sanitary District in	
	Paragraph 1 above, the Town shall issue a satisfaction or partial satisfaction, as applicable, to the	
	Sanitary District.	
4.	Binding Effect.	
	This Promissory Note shall be binding upon the parties hereto, their heirs, successors and assigns. All	
	disputes shall be controlled under the laws of the State of Wisconsin as the same control commercial	
	transactions.
